Paragraph 1, Rules - Class rules, where applicable, will be those adopted by local fleets for DRYA participation.

Paragraph 16, Protest is modified to read as follows:
"Submit written protest to the GPYC Switchboard (Front Desk) within two hours of your finish. Protests will be heard at the Bayview Yacht Club at 19:30 hours, Monday, August 16.
